As sought for in your letter under reference, the requisite information is furnished as under:-

- i. e-Filing for commercial disputes in Commercial Courts
 - Enabled.
 - e-Filing 3.0 is enabled for all courts under the jurisdiction of the High Court of Meghalaya since March 2024 however till date 0 cases are eFiled.
 - To ensure smooth implementation of eFiling, Rules have been notified and training have also been imparted to the court staffs, Judicial Officers and Advocates through the Meghalaya State Judicial Academy where the services of the Judicial Officers Master Trainers, Manager IT, Advocate Master Trainers, Potential Master Trainers, CPCs Technical Team are utilized on a regular basis.
 - Further, it may also be mentioned that there are no technical impediments being faced by the High Court and the District Courts to optimally switch over from physical filing to eFiling however the Advocates are not utilizing the facility for eFiling of cases inspite of numerous trainings conducted through the Meghalaya State Judicial Academy.

- ii. Issuance of e-Summons for commercial disputes in Commercial Courts

- Facility Available.
 - The N-STEP (National Service and tracking of Electronic Processes) Mobile app is utilized for delivery of processes to the litigants by the Process Servers/Bailiffs. For NSTEP implementation, Smart phones have been provided to the Process Servers of all Court Complexes under eCourts Phase II & III project.

- iii. Publishing of e-cause lists for commercial disputes in Commercial Courts
- e-Cause lists for commercial disputes in Commercial Courts is being published on a daily basis and the same can be accessed from the District Court Shillong Website.
