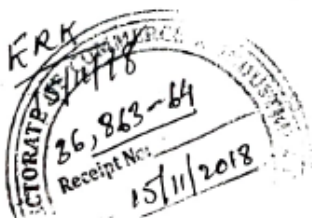

THE DISTRICT EXPORT PROMOTION COMMITTEE
HELD ON THE 7TH JULY, 2025 AT 12.00 PM
IN THE OFFICE CHAMBER OF THE DEPUTY COMMISSIONER,
RI-BHOI DISTRICT, NONGPOH**

Members Present at Annexure A

At the outset, the Deputy Commissioner, Ri-Bhoi District, Nongpoh and Chairman of the District Export Promotion Committee, Shri. Abhilash Baranwal, IAS welcomed all the members present and initiated discussion as per the following agenda

1. Shri. W. Warshong Deputy Director (T), Commerce & Industries Department informed the House that the purpose of this meeting is to meet with all the new members of the Committee as decided on the 1st Meeting. However, since some of these members from outside the District could not be present for the meeting. Shri W. Warshong requested the Chairman if the meeting could be conducted in **Hybrid mode** so that Members from outside the District can attend the meeting conveniently. The Chairman agreed on this and it was decided that subsequent meetings of the DEPC will be conducted on Hybrid mode.
2. Shri W. Warshong emphasized that one of the important Agenda of this meeting is to initiate the preparation of the **District Action Plan**. The Action Plan will be prepared by DCIC in consultation with DGFT and MSME. In this regard, DGFT will share template for the preparation of District Action Plan with DCIC, Nongpoh. Further, coordination with other Departments e.g. Horticulture, NABARD, Industries Association etc for Export related data is essential for preparation of this Action Plan.
The Chairman had set an initial timeline of 1 month for completion of this Action Plan; however, extension will be provided if required.
3. Shri. Garav Bajaj, Umiam Industries Association, RNB Group informed that there is a potential to explore the export market for **Ferrosilicon** from Ri-Bhoi District to Japan, therefore he has requested DGFT to share details of buyers from Japan in order to explore the market for this product in Japan. He also mentioned that **Briquettes** which is used as a biofuel is another product that may be considered for exploring the export market. For the same, he has requested DGFT to share the buyers' details of this commodity to examine the viability of exporting this product.
4. Shri. Ashish Bhoutika, YP, DGFT, Guwahati informed the house that DGFT has certain funds allocated for conducting of Awareness Programmes. This fund can be utilized to sensitize Exporters, potential Exporters, Entrepreneurs on the various procedures and documentations relating to exporting of product to other countries.
In this regard the Chairman requested GM, DCIC, Nongpoh to identify suitable venues and participants for conducting the Awareness programme

The Meeting concluded with a vote of thanks from the Chair.
