The TSU will be required to assist the NPG and provide expertise for integration of interconnected multimodal network transport and infrastructure for efficient movement of people, goods and services; optimization of logistics assets by promoting collaboration and synergetic usage, improving decision making through effective logistic data analytics; standardization through streamlining of processes and digital information for increasing productivity across different modes of transport; modernization through digital transformation and increased automation.

The Technical Support Unit may engage experts from the Market, if required, with prior approval of the Empowered Group of Secretaries/Network Planning Group.

- 4. It is through the GIS platform-based system, NPG will monitor all the interventions in the Master Plan and prepare periodic reports for review by the EGoS on the implementation.
